and Air Force. The U.S. Armed Forces also
includes the Coast Guard. The Public
Health Service and the National Ocea-nic
and Atmospheric Administration can also
receive many of the same tax benefits.
The U.S. Armed Forces doesn't include the
U.S. Merchant Marine or the American Red
Cross. Members serving in an area
designated or treated as a combat zone
are granted special tax benefits. In the
event an area ceases to be a combat zone,
the IRS will do its best to notify you. Many
of the relief provisions will end at that
time.
