The electromagnetic field extends indefinitely throughout space and describes the electromagnetic interaction. The field can be viewed as the combination of an electric field and a magnetic field. Electric and magnetic fields (EMFs) are areas of energy that surround electrical devices. The electric field is produced by stationary charges, and the magnetic field by moving charges (currents); these two are often described as the sources of the field.
