What is New to This Edition Vector transformations in different coordinate systems have been included in the chapter on Vector Analysis. The treatment forms the basis of

vector potentials for three-dimensional problems. Chapter 13 on Vector Potentials has been significantly expanded for a clear understanding of the properties of vector potentials, in order to also solve three-dimensional EM problems numerically.
